Vacancy for Post of Monitoring Officer

Applications are invited from qualified candidates who wish to be considered for appointment to the post of Monitoring Officer, on a permanent and pensionable basis, in the Independent Broadcasting Authority.

I. AGE LIMIT

Candidates should not have reached their 45th birthday by the closing date for the submission of applications.

II. QUALIFICATIONS

- A. A Diploma in Mass Communication or an equivalent qualification in any other related field acceptable to the Board.
- B. Candidates should -
 - (i) possess good analytical, interpersonal and communication skills; and
 - (ii) be computer literate.
- NOTE 1: (i) The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.
 - (ii) The Independent Broadcasting Authority reserves the right
 - a) to convene only the best qualified candidates for interview; and
 - b) not to make any appointment following this advertisement.
 - (iii) Candidates should produce documentary evidence of knowledge claimed.

III. <u>DUTIES:</u>

- 1. To be responsible to the Head, Monitoring and Compliance, through the Compliance Officer, for the performance of the following duties-
 - (i)to assist the Compliance Officer in the day to day running of the Monitoring and Compliance Unit;
 - (ii) to be responsible for the timely monitoring of Radio and TV programmes for the preparation of accurate daily high-quality monitoring reports;
 - (iii)to prepare transcripts of Radio/ TV programmes, as and when required;
 - (iv)to identify any breach of the Independent Broadcasting Authority Act 2000, and related codes, and inform Compliance Officers accordingly for necessary investigation;
 - (v)to assist Coordinators to compile daily highlights of news items broadcast in main news bulletins; and
 - (vi)to communicate, in a timely manner, daily early morning highlights to Compliance Officers and Management.
- 2. To use ICT in the performance his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Monitoring Officer, in the roles ascribed to him.

NOTE 2:

The Monitoring Officers will be required to work outside normal working hours including Saturdays, Sundays and Public Holidays.
