## **THE INDEPENDENT BROADCASTING AUTHORITY ACT**

### **Regulations made by the Authority under section 38(3)(a) of the Independent Broadcasting Authority Act**

1. These regulations may be cited as the Independent Broadcasting Authority (Licence Fees) (Amendment) Regulations 2021.
2. In these regulations –  
“principal regulations” means the Independent Broadcasting Authority (Licence Fees) Regulations 2002.
3. The principal regulations are amended by adding the following new regulation –
  5. Notwithstanding anything contrary in these regulations, a licensee which has been in operation for a period of less than 5 years shall pay 50 per cent of the fees specified in the Schedule.
4. The Schedule to the principal regulations is revoked and replaced by the Schedule set out in the Schedule to these regulations.
5. These regulations shall be deemed to have come into operation on 1 January 2021.

Made by the Independent Broadcasting Authority on 22 March 2021 and approved by the Minister on 29 March 2021.
